

Disciplinary Regulations for Students of the Third Faculty of Medicine of Charles University

The Academic Senate of the Third Faculty of Medicine of Charles University, pursuant to Section 27 (1) (b) and Section 33 (2) (e) of Act No. 111/1998 Coll., on Higher Education and on Amendments and Additions to Other Acts (the Higher Education Act), as amended (the Higher Education Act), and pursuant to Article 10 (1) (b) of the Statutes of the Third Faculty of Medicine of Charles University, as amended, has resolved to adopt these Disciplinary Regulations for Students of the Third Faculty of Medicine of Charles University as its internal regulations:

Article 1

Introductory provisions

Disciplinary offences of students enrolled at the Third Faculty of Medicine of Charles University (hereinafter referred to as "Faculty" and "University"), the imposition of sanctions for such offences, disciplinary proceedings and details of the Faculty Disciplinary Committee (hereinafter referred to as "Committee") are regulated by the Higher Education¹, the Administrative Code, the Disciplinary Regulations for Students of Charles University and these Regulations.

Article 2

Disciplinary Committee of the Faculty

1. The Commission has six members, half of whom are students. The alternates are two academic staff and two students.
2. The term of office of the members of the Commission shall be two years and shall begin upon appointment.
3. Membership of the Commission shall cease
 - a) at the end of the term of office,
 - b) before the expiry of the term of office
 - i. termination of membership in the academic community of the faculty,
 - ii. the date of delivery of a written statement to the Dean by which the member or alternate resigns from membership or alternate membership on the committee,
 - iii. removal of a member of the committee by the dean with the prior approval of the academic senate of the faculty.
4. A replacement appointed by the Dean shall take the place of the member of the Board whose seat has been vacated pursuant to paragraph 3(a) and (b) for the remainder of the term of office of the member whose seat has been vacated.

Article 3
Rules of procedure of the Commission

1. If the Board receives a proposal to initiate disciplinary proceedings against a Board member or alternate, that member or alternate shall be excluded from consideration of the matter.
2. The Commission shall decide by secret ballot if at least one of its members so requests.
3. The dean's office provides assistance to the Commission.

Article 4
Transitional provisions

1. Disciplinary proceedings commenced before these Regulations come into force shall be completed in accordance with these Regulations and the Disciplinary Regulations for Students of Charles University.
2. The term of office of a Disciplinary Board appointed before the entry into force of these Rules shall remain unaffected.

Article 5
Final provisions

1. The Disciplinary Regulations for Students of the Third Faculty of Medicine approved by the Academic Senate of the University on 6 June 2003 are hereby repealed.
2. These rules were approved by the Faculty Senate on 18 April 2017.
3. These Regulations shall come into force on the date of approval by the Academic Senate of the University²
4. These Rules shall come into force on the first day of the calendar month following the day on which they come into force.
