Swiss-European mobility and cooperation in education: Funding opportunities for 2018-2020

Dear Madam, Dear Sir,

Within the European education programme Erasmus+, Switzerland has the status of a third country ("partner country" in the Erasmus+ terminology). Swiss institutions can only participate in a reduced number of activities and only under the conditions applying to organisations from "partner countries" as described in the Erasmus+ programme guide.

To ensure the continuity of the mobility activities and cooperation of Swiss education institutions with the Erasmus+ programme countries, the Swiss Federal Council has established a Swiss-funded interim solution for Erasmus+ 2014-2017.

In the coming weeks, the Swiss parliament will decide on the Federal Council's proposal to maintain and develop these funding opportunities in the years 2018-2020. Both Switzerland and the European Commission agreed that it would be the most efficient way forward to concentrate further efforts on an association of Switzerland to the successor of Erasmus+.

For higher education mobility projects, the main features of the Swiss indirect participation to Erasmus+ in the years 2018-2020 are:

- Funding for higher education mobility projects is provided under the Swiss-European Mobility Programme (SEMP), it follows the principles of Erasmus+;
- Student mobility for studies and staff mobility for teaching are based on inter-institutional agreements between Swiss and European higher education institutions (HEI);
- Swiss HEIs can apply for Swiss funding of outgoing and incoming mobility activities (key action 1) with any Erasmus+ programme country. The grants for both outgoing and incoming mobilities will be paid by the Swiss HEIs to the ultimate beneficiaries;
- The activities include all types of mobility: student mobility for studies and student mobility for traineeships, staff mobility for teaching and staff mobility for training. Traineeships in Switzerland can only be funded if they are coordinated by a Swiss partner HEI;
- In 2017, the amount awarded to students coming to Switzerland for study purposes is between CHF 360 and CHF 420 (approx. EUR 310-370), for traineeships CHF 420 (approx. EUR 370). Although the amount for 2018 has not yet been set, no substantial changes are to be expected.


Swiss HEIs can participate in Erasmus+ cooperation projects (Strategic Partnerships, Knowledge Alliances and Sport Partnerships) in two ways:

- Either within the framework of the interim solution, i.e. Swiss HEIs can participate in Strategic Partnerships, Knowledge Alliances and Sport Partnerships as “associated partners” and apply for national funding.
- Or Swiss HEIs can participate in Strategic Partnerships, Knowledge Alliances and Sport Partnerships as “full partners” (benefiting from funding from Erasmus+) on condition that they bring added value to the project.
